All parade participants will queue on Ivy Ave, between 1st & 3rd streets. Walkers will use adjacent parking lots, vehicles will stage on Ivy Ave.

Route (see image below):

- > The parade will travel south on Ivy Ave to 3rd St/Hwy 131
- > Turn east (left) on 3rd St and continue down 3rd St to Laurel Ave
- > Turn north (turn left) on Laurel Ave down to 1st St
- > Walking groups will turn west (left) on to 2nd St to disband
- > Vehicles will turn west (left) on 1st St to disband

Line-up will start at 4:30 pm, and all entries must be checked in by 5:15 pm and ready to leave by 5:15 pm\*.

\*This parade coincides with the Tree Lighting Ceremony at City Hall. Depending on the length of the Tree Lighting entertainment and other activities, the parade may start a bit sooner or a bit later than 5:30. Participants are to be in line and ready to leave by 5:15 pm.

## Tillamook Holiday Light Parade Participant Instructions

~ No entry fee is required ~

You are cordially invited to participate in the Tillamook Holiday Light Parade. Your prompt submission of our entry form will assist in making this a smooth and fun parade for all.

The Tillamook Holiday Light Parade starts at approximately **5:30 pm** on December 7th, from intersection of Ivy Ave & 3<sup>rd</sup> St. Participants are to be checked in, lined up, and **ready to leave by 5:15 pm.** 

Alcoholic beverages and other controlled substances are strictly prohibited. Participants consuming a controlled substance will not be permitted to enter the parade. Participants consuming a controlled substance, during the parade, or in the staging area will not be allowed to participate in future parades.

All parade entries must be illuminated, including walkers.

\*\* No material, of any kind, may be handed out or thrown along the parade route. Persons in the parade are prohibited from distributing merchandise, gifts, literature, or other materials. Throwing candy is strictly prohibited! \*\*

Honking of horns is not allowed.

Please maintain a forward motion at all times - participants must keep pace with the line of march - do not mingle with spectators.

<u>Dogs</u>: Dogs are welcome to participate in the parade but must be a minimum of 16 weeks old, licensed, and current on all vaccinations.

Dogs must be kept on a leash at all times during the event.

Dog handlers must clean up after their dog, obey all traffic laws, exercise safety precautions, avoid littering, and maintain full control of their animal at all times.

All entries must provide (by November 30th, 2024):

- Completed entry submission
- Description of entry
- Proof of insurance as indicated above for motor vehicles and equestrian entries

Entries must follow all applicable rules and regulations, or risk being barred from the parade.
